Policies and Procedures:

All estimates are based off customers submitted roadway measurements and are subject to change as the driver measures during the application. Any need for pilot cars, traffic control, or additional permits can and will increase pricing. Any discrepancies must be brought to our attention within 7 days of invoicing.

We have to juggle Federal, State, County, and Municipality schedules and we are not always told when they will be grading your roadway - so please be patient. If you know when they are grading, and email to us is always help in order to schedule accordingly.

Although we try to accommodate schedules for some of our smaller jobs, full truckload jobs can and will take priority with smaller footage jobs scheduled around them. Scheduling is primarily Monday - Friday, weekend or holiday requested spray dates will have additional pricing. (This does not apply to jobs that we choose to add in around requested dates in order to fill a route.)

Please have your area/job site prepared and ready to go, we often don't know when we will be in your area again if we miss you. Please mark start and stop with our given ribbons or with paper plates with your last name/start/stop. Ribbons must be out during the day of application for neighborhood discounts to apply otherwise full pricing rates will be applied.

We are not responsible for "Mother Nature"...severe weather can and will affect your roadway treatment application and effectiveness, we will do our best to schedule around these, rain or forecasted rain will delay application and scheduling. Our warranty is that you will have 30 days to determine if there was an application or product issue. Our limited warranty is only applicable if the roadway has been properly prepared, depending on product, before application.

The county may periodically grade areas where dust suppressant has been applied should they determined it to be in the best interest of the traveling public. In such instances our warranty will be nullified. Bring this up with your county road department/or commissioners. We can reapply dust abatement product for an additional fee upon request.
